

Major renewal of ageing English roads delivered with £27 billion investment

26.3.2026 - | Her Majesty's Revenue and Customs

Road Investment Strategy 3 will fund major schemes to upgrade and future-proof England's roads over the next 5 years.

- major £27 billion boost for England's motorways and major A-roads over the next 5 years - one of the largest ever road investment plans
- after years of decline, plans will fix the country's ageing roads, fund major schemes like the dualling of the A66 and unlock private investment into the Lower Thames Crossing to improve connectivity and cut congestion
- government also gives green light to 16 key road schemes on local roads, helping create thousands of new jobs and homes across the country

Millions of drivers are set for smoother, safer journeys as the government today (26 March 2026) commits £27 billion to upgrade and future-proof England's roads.

Spread across 5 years, the plan puts more money into maintaining the network to help deliver smoother, more reliable journeys for drivers, businesses and freight operators by resurfacing roads, fixing potholes, and replacing worn-out stretches of motorway.

The huge investment, known as the Road Investment Strategy (RIS3), will fund major schemes that unlock growth and improve connectivity across the country, and allow National Highways (NH) to resurface over 9,000 kilometres worth of motorway and major A-road lanes - almost a quarter of the network.

These include the dualling of the A66 between Cumbria and North Yorkshire, and government support to bring private investment into the Lower Thames Crossing - a new road crossing east of London that will ease congestion and improve connections across the South East.

The government is also choosing to fix the foundations, investing a record £8.4 billion to repairing and renewing England's motorways and major A-roads before problems arise, so drivers can have faith in a world-class road network once again.

That's on top of the £7.3 billion already pledged by government at the Spending Review for local authorities to fix potholes and invest in long-term measures to maintain local roads.

To help restore people's pride in their communities, the government is today also giving the green light to a further 16 road schemes on the major road network and local roads, supporting thousands of new jobs and homes in communities across England.

The schemes, including bypasses and junction improvements that local authorities could not deliver alone, have been chosen on their value for money and long-term deliverability, ensuring taxpayers' money goes into projects that will deliver growth for left behind communities.

To help show the scale of the investment, the government has created an interactive map showing all the schemes that will be progressed during RIS3.

Transport Secretary, Heidi Alexander, said:

For too long this country has failed to tackle and fix our crumbling infrastructure, but this huge £27 billion investment in our roads will secure the future of our road network for years to come.

Not only are we investing in renewing our roads, meaning smoother and faster journeys for drivers, we are getting on with investing into brand new projects and fixing potholes, which will deliver benefits across the country from Norwich to Manchester.

Roads and Buses Minister, Simon Lightwood, said:

This government is firmly putting its money where its mouth is, and this new funding will be transformational for the millions of drivers and thousands of businesses that rely on our motorways and A roads every day.

By investing in existing infrastructure and new schemes, such as the Lower Thames Crossing and long-awaited dualling of the A66, we are giving everyone the confidence they can get from A to B faster and smoother than ever before.

National Highways Executive Director Elliot Shaw said:

This major investment will help boost economic growth by improving and maintaining motorways and major A roads which keep the country moving.

When roads are well maintained, businesses and communities feel the benefit, so this funding enables us to tackle an ageing network head-on and keep drivers safe.

Our focus on renewing vital infrastructure will keep people connected to their loved ones, support the delivery of new homes and jobs, and give industry the confidence to plan and invest in the UK.

The £27 billion investment supports the government's central mission of kickstarting economic growth, giving businesses and regions the long-term certainty they need to invest and create jobs. Improved road reliability will also help keep supply chains moving and support the freight networks that keep goods and prices stable for consumers.

RIS3 sets stretching targets for National Highways on safety, journey reliability, network condition and environmental performance, allowing the government to hold them to account on delivery over the 5-year period.

While today the government has committed to tackling potholes on motorway and major A-road surfaces, it also recently committed to investing over £7 billion over the next 4 years to help councils tackle their potholes. We have also introduced a new rating system so people can see for themselves whether their local council is using their funding to deliver for their communities.

Scheme	Region	Description
A66 Northern Trans-Pennine	North East, North West, and Yorkshire	Dualling of the remaining single-carriageway sections of the A66 between the M6 Junction 40 and A1(M) Junction 53, and improvements to the junctions at Penrith and Scotch Corner.
M180 Junction 2-3 Eastbound and Westbound	Yorkshire	An ageing concrete road that requires full reconstruction.
A180 Brocklesby Interchange to Barnetby Interchange	Lincolnshire	Ageing concrete road that requires full reconstruction. The road is a key route serving Immingham Docks and the Port of Grimsby.
M62 Goole and Airmyn refurbishment	Yorkshire	Refurbishment of 2 bridges. This project will repair the structures, renew key components, and install measures to protect them from future damage.
Mottram Moor Link Road and A57 Link Road	North West	New dual carriageway bypass from M67 Junction 4, around Mottram, and new single carriageway link road.
M60 / M62 / M66 Simister Island	North West	Improving capacity of the intersection between the M60 Junction 18, M62 and M66.
M6 Lune Gorge	North West	Renewing ageing bridges along a 10km stretch between Junctions 37 and 38. These structures were built in the late 1960s and are now deteriorating due to their design and today's heavier traffic. Without intervention, traffic would eventually face lane reductions and full closures.
M54 to M6 Link Road	West Midlands	New dual carriageway link road between the M54 Junction 1 and M6 Junction 11.
A46 Coventry Junctions	West Midlands	Upgrading the Binley and Walsgrave junctions on the A46 to grade separated.
M42 Junction 6	West Midlands	New dual carriageway link road from a new junction (5a) on the M42, to an upgraded M42 Junction 6.
A46 Newark Bypass	East Midlands	Dualling of the existing A46 single carriageway between Farndon and Winthorpe roundabouts in Newark.
A38 Derby Junctions	East Midlands	Replacement of 3 roundabouts on A38 with grade-separated interchanges.
A52 Nottingham Junctions	East Midlands	Improving capacity at several junctions along the A52 in Nottingham.
A46 concrete reconstruction	East Midlands	This project will deliver reconstruction of the affected section to provide a safer, more resilient, and more reliable route.
M42 Eastway Bridge	West Midlands	This project will address these structural issues, keep the bridge safe and ensure reliable access to the NEC and surrounding area.
A428 Black Cat to Caxton Gibbet	East	New 10-mile dual carriageway section between Cambridge and the M1, including 3 grade separated junctions.

A47 Blofield to North Burlingham	East	Upgrading of the existing A47 to dual carriageway between Blofield and North Burlingham, east of Norwich.
A47 North Tuddenham to Easton	East	Dualling of the existing A47 single carriageway between Norwich and Dereham.
A47 Thickthorn Junction	East	Two new slip roads that will connect the A47 with the A11.
M25 Junction 10	South East	Improving capacity of the junction with the A3 Wisley Interchange.
M3 Junction 9	South East	Upgrade to the junction to allow free movement from the A34 to the M3.
M27 J5-7 concrete overlay	South East	Upgrades to the central barrier and drainage to extend the life of this section of the M27 by around 40 years.
Arundel Railway Bridge Replacement	South East	A viable replacement option is currently being developed.
A417 missing link	South West	New dual carriageway connecting the 2 dual carriageway sections of the A417 near Birdlip in Gloucestershire.
M32 Eastville Viaduct renewal	South West	In need of significant renewal to ensure it remains safe and reliable. The project will repair and strengthen the structure so it can continue to serve its full design life, helping to maintain a key route into the city.
M5 J19-20 Wynhol Viaduct	South West	Requires significant work to address ageing structures and ensure the route remains safe and reliable for road users. This project is at an early development stage, and the scope is still being developed.

M1 Junction 28	East Midlands	Junction improvements to support growth by reducing congestion on key transport corridor of the M1 and A38.
A404 Corridor improvements	South East	Improvement of 2 junctions to support significant growth in and around Thames Valley.
M27 Junction 3	South East	Improves access to the Port of Southampton, the main port for UK manufactured goods exported outside the EU.
A5 / M42 Junction 10	West Midlands	Unlocking economic and housing growth by easing congestion on the A5 where it meets Junction 10 of the M42.
A5 Dodwells to Longshoot	West Midlands	Improves performance and capacity of the A5 to support commercial and housing growth.
A50 Corridor	West Midlands	Improving 4 junctions along the A50 corridor and improving links to the M1 and M6.
M6 Junction 15	West Midlands	Reducing congestion and increasing capacity at this key junction, supporting wider growth of the A50 corridor.
A5 Gibbet Hill	Midlands	Supporting significant planned commercial and housing growth in the region.
A19 Moor Farm Junction	North East	Delivering junction improvements to support significant planned housing and commercial growth in the North East.

M62 / A57 Link	North West	Addressing a major pinch point at Junction 11-12 of the M60 and significant delay on the corridor, while also supporting growth and developments within the new mayoral development zone at Western Gateway.
M1 Junction 13	East	Delivering improvements to the junction connecting the A421 and the M1, in response to significant regional growth.
A12 / A14 Copdock Interchange	East	Delivering improvements to increase capacity and improve the performance of a key junction serving freight traffic bound to and from the Port of Felixstowe.
A11 Fiveways Junction	East	Improving a key junction to support regional growth.

A650 Tong Street	Carriageway widening to 2 lanes in each direction and improvements to active travel facilities

A43 Northampton	Phase 3 of dualling of the A43 between the A45 and A14. Duals the stretch between Overstone Grange Roundabout and Holcot / Sywell Roundabout.
A379 Bridge Road (formerly Exeter Outer Ring Road)	Major structural renewals on a key arterial route over the River Exe.
M5 Junction 28	Improvements to junction to mitigate impacts of Culm Garden Village development.
Northam Rail Bridge	Provision of a new, widened, replacement bridge on the A3024 corridor in Southampton.
A229 Blue Bell Hill Improvements	Upgrade of junctions at either end of Bluebell Hill: A229 / M2 J3 and A229 / M20 J6.
A259 south coast corridor	Measures to enhance access to public transport and active travel facilities alongside localised road and junction capacity improvements.
A326 Waterside improvements	Improvements to the A326 Corridor connecting into the M27 at Junction 2 and serving the Waterside area of the New Forest.

Wigan East West	A link road connecting the A49 at Wigan to the A58 at Hindley.
Sunderland strategic transport corridor phase 4	Improvements to the A1231 between the new bridge over the River Wear and the junction with the A19.
